3) SCRUTINEER DECLARATION

I hereby declare that I will, in all respects, maintain and aid in maintaining the absolute secrecy of the vote and the identity of all voters. I agree not to disclose any election results to anyone until results are made public by the Chief Returning Officer (CRO). I will surrender all electronic devices including phones, iPods, and any other device capable of transmitting messages, from the time I arrive at the elections office until the CRO releases the unofficial results. Furthermore, I will remain in the elections office for the entirety of the scrutineer processes, leaving only when escorted by elections staff to use the washroom and that absolutely no other exceptions will be made. I understand that, as a scrutineer, the only additional privileges I am extended are to visit voting stations and be present at the counting of ballots to ensure fairness and to see that due process is being followed. I will not physically touch voting station supplies, ballots or restricted election material, nor will I approach individual voters or interfere with the operation of any aspect of the election. I understand that if I violate SU Elections Bylaw or any other election rules, the candidate or side for which I represent may be subject to penalty, most likely including disqualification.
