## DIRECTOR OF RESEARCH AND ADVOCACY

- Began writing Identity Matters 3 for VPX, anticipated delivery first week of February pending Annual Survey data.
- Team is repeating the accessibility portion of the 2019 review of a dozen student spaces around North Campus.
- Meeting with some committee chairs and developing additional support structure.
- After the new announcement, provincial student grant funding has kept up with enrolment and inflation but Alberta's loans-to-grants imbalance remains severe. It now sits at 7 cents of grants per dollar of loans, stable from the last two years, down significantly from past-five-year and past-ten-year averages.

# ASSISTANT MANAGER, GOVERNANCE SUPPORT

- The large majority of Students-at-Large have been appointed.
- Council jackets are largely arranged.

- New Governance Support Specialist starting soon.
- Will not be here for the next Students' Council.

#### STUDENTS' COUNCIL

Arc Cards/U-Pass

- ETS is not giving Arc Cards to students this year, and proposals have not been satisfactory (e.g. proposed extra charges to students, distribution feasibility). The Executives discussed how to engage with this issue. FLAMAN and BEASLEY will be meeting with the U-Pass committee and the City, respectively. This issue needs to be resolved over the summer.
- This year we will need around 6,000 cards for new students.
