Part of the Student Union Dedicated Fees goes to Alberta Public Interest Research Group (APIRG). One of APIRG's funded groups is the Palestine Solidarity Network (PSN), which annually hosts Israeli Apartheid Week and seeks to "advance the Palestinian Boycott, Divestment and Sanctions movement." APIRG's decision to fund this controversial hate-fest reflects a very poor decision.

Falsely accusing Israel of apartheid is done to delegitimize Israel by comparing it to apartheid South Africa. Singling out the Middle East's only free democracy is unfair and immoral, especially when their accusations are all based on a lie. PSN also invites controversial speakers who spew lies, even comparing the Jewish State of Israel to Nazi Germany.

There is something fundamentally and morally wrong in an organization that actively promotes this mentality with false analogies. It is a shame that APIRG has no qualms in sponsoring such a group. While recognizing the right of free speech on campus, I do not wish to shut down these events. The issue is whether APIRG's funding is consistent with values of decency and morality. Those who fund hateful events become complicit in propagating that message of hate

I suggest that there should be an easier APIRG opt-out system available for students such as a simple and quick online form similar to the one for opting out of the health and dental plans. When student money that is optional and is being used for activities of such ideologies, then there also needs to be much better communication to all the students. Perhaps an email sent out describing the option of opting out, a link to the opt out website, and an explanation of what the money is being used for detailing every funded group and its activities. Students have a right to know, and to have the information more easily accessible. Please ensure that the students' money does not go towards such inappropriate activities, call for more responsible use of student money, and correct this injustice in the fight against bigotry and hate.
