The rate of international students transitioning from temporary to permanent resident status in the past decade has not kept up with the pace of international student enrollment in Canadian post-secondary institutions\*

- The University of Alberta clearly recognizes the importance of international students
- A diverse student body and institutional internationalization is a fundamental feature of a high-quality university education
- Although post-secondary institutions may charge international students more than domestic students, international students should not bear the burden of an institution's financial deficits
- The International Student Differential Fee limits the geographic diversity of our international students because it selects for students in regions where more affluent families can afford education aboard
- The International Differential Fee is a fabricated fee by postsecondary institutions and is not regulated by the Government of Alberta or the Public Post-Secondary Institutions' Tuition Fees Regulation
- International students have less access to Scholarships and do not have access to Government Student Loans. Furthermore, scholarships available to international students are of complex requirements and difficult to renew and/or regain if lost
- An enhanced campus experience may increase engagement and retention of international students. Research has shown that the lack of integration with domestic students, little accessibility of on-campus housing, and the inadequate quality of career-related programming are the top three issues for international students studying in Canada\*
- Employers in Canada value cultural awareness and global experiences as important attributes in a multicultural work environment

WHEREAS public transit is a common mode of transportation used by University of Alberta students that benefits the quality of life of all members in the community;

WHEREAS the U-Pass is to be implemented in the academic years consistent with the referendum conditions;

WHEREAS the post-secondary bus pass provides a more affordable public transit option for students than a regular adult pass;

WHEREAS public transit expansion would allow improved access for University of Alberta students to commute within the service area;

WHEREAS light rail transit (LRT) is an efficient and reliable form of public transit

WHEREAS Smartcard technology would reduce the possibility for U-pass fraud and reduce the need for a U-Pass replacement fee;

WHEREAS University of Alberta students enrolled in spring and summer classes spend a significant amount o time commuting to and from campus;

WHEREAS University of Alberta students enrolled in spring and summer classes should be able to obtain a spring and/or summer U-Pass regardless of the student's full-time or part-time enrollment status;

BE IT RESOLVED THAT the Students' Union advocates that the regional municipalities and transit services carefully monitor service demand arising from U-pass implementation, consider input from stakeholders and commit all resources necessary to maintain reliable, safe and timely service;

BE IT FURTHER RESOLVED THAT the Students' Union advocates for a more affordable option than a regular adult pass for <u>part-time</u> spring and summer students;

BE IT FURTHER RESOLVED THAT the Students' Union negotiate a new, long- term U-Pass contract to be implemented upon the expiry of the current contract; and

BE IT FURTHER RESOLVED THAT the Students' Union advocates that the regional municipalities and transit services expand their current service systems, prioritizing LRT, and the implementation of Smartcard technology, to better meet the needs of the University of Alberta students-; and

<u>BE IT FURTHER RESOLVED THAT the Students' Union advocate for the integration of Smartcard technology into the One Card system.</u>

**Comment [A1]:** Removed because PC felt it was repetitive. The term "Public Transit" in Edmonton covers both the bus and the LRT.

**Comment [A2]:** Added to reflect the need to negotiate a part-time spring and summer U-Pass since. Currently, only full-time students get to use it. Even if a student is part time, they would have to commute to campus 5 days/week for most classes since terms are very short and classes run every day.

**Comment [A3]:** We already have a pass for fulltime students. We do not have one for part-time spring and summer students.

**Comment [A4]:** There is a need to reduce U-Pass fraud and find a solution to the way fees are managed. One suggestion is integration into the one card system through smartcard technology. That way students are less likely to forget it.

# INTERNATIONALIZATION

WHEREAS the number of international students in Canada has increased by 148 percent from 2002 to 2011<sup>1</sup>;

WHEREAS the number of international students transitioning from temporary to permanent resident status increased by 16 percent from 2002 to 2011<sup>1</sup>;

WHEREAS the rate of international students transitioning from temporary to permanent resident status in the past decade has not kept up with the pace of international student enrollment in Canadian post secondary institutions;

WHEREAS <u>the linternational student - differential Differential Fee (IFD)</u> represents a serious threat to affordability and accessibility;

WHEREAS international students have less access to merit-based and needbased aid, and do not have access to Government student loans;

WHEREAS renewable scholarships for international students are important for their financial planning and cannot be regained if lost;

WHEREAS post secondary institutions may charge international students more than they cost to educate;

WHEREAS international students should not bear the burden of <u>an</u> institutions' financial deficits;

WHEREAS the University of Alberta <u>and the Students' Union clearly</u> recognizes the importance of international students;

WHEREAS the Government of Alberta does not require educational institutions to charge international student differential fees;-International Differential Fees (IDFs);

WHEREAS the Public Post-Secondary Institutions'Institutions Tuition Fees Regulation makes no provisions for international student differential fees; -does not regulate International Differential fees (IDFs);

WHEREAS <u>the linternational student t differential Differential Fee</u> limits the geographic diversity of our international students;

WHEREAS international students may work in Canada for up to three years after completion of their program and may also apply for landed immigrant status;-

WHEREAS a diverse student body and institutional internationalization is a fundamental feature of a high-quality university education;

WHEREAS an enhanced campus experience may increase engagement and retention of international students;

WHEREAS recent surveys have shown that: a) integration with domestic students, b) accessibility of on-campus housing, and c) quality of career-related programming are the top three experiences international students seek in their post-secondary experience;

WHEREAS studying abroad is a unique and highly valuable experience that all University of Alberta students should be able to access;-

WHEREAS the transfer credit system plays a pivotal role in enhancing the quality of internationalization at the University of Alberta; <u>and</u>

WHEREAS cultural awareness and global experiences are highly sought-after attributes by potential employers.

BE IT RESOLVED THAT the Students' Union shall support accessible postsecondary education for international students at the University of Alberta;

BE IT FURTHER RESOLVED THAT the Students' Union shall not support the Board of Governors of the University of Alberta increasing-<u>International</u> Ddifferential tuition <u>-Fees for international students;</u>

BE IT FURTHER RESOLVED THAT the Students' Union shall advocate to the University to provide international students with the support and services needed to help them achieve success in the pursuit of a quality undergraduate experience; and BE IT FURTHER RESOLVED THAT the Students' Union advocates shall advocate that to the University of Alberta for -provide clear and transparent transfer credit processes at the faculty, Campus Alberta, national, and international levels-:

<u>BE IT FURTHER RESOLVED THAT the Students' Union shall advocate the</u> <u>University of Alberta to improve access to merit-based and need-based aid for</u> <u>international students;</u>

<u>BE IT FURTHER RESOLVED THAT the Students' Union shall advocate the</u> <u>University of Alberta to restructure renewable scholarships to provide more</u> <u>predictability</u>;

# **UASU Health & Dental Plan**

## Background: Definitions, Historical Context, and Projections

The *plan premiums* are the amount paid by the SU to the insurer (Desjardins) and the plan administrator (studentcare.net/works. This is strictly to purchase the package of benefits and services required to provide a Health & Dental Plan to SU members.

The *plan fees* are the total amount paid by students, and includes premiums as well as an amount allocated to the SU Reserve Fund, which was initiated at the Plan's inception to ensure long-term cost stability, and the ability for the SU to engage in long-term strategic planning.

As your plan administrators and consultants, studentcare.net/works performs an analysis of the Plan's claims experience, uses our leverage and negotiation to control inflation and administrative expenses, and ultimately presents the lowest insurer quoted rates to the SU for consideration. The table below is a simplified formula of how premiums are calculated.

Perhaps most important to note is that claims drive 90% of the cost of the Plan.



The results of the renewal analysis conducted by studentcare.net/works, as confirmed by Desjardins and presented to the Health & Dental Plan Committee, are as follows:


## **Background: Impact of Past Strategies**

The previous Insurer, Sun Life, was quoting premium increases as high as \$237.00 in 2012. Judging market conditions to be right for a competitive RFQ (Request for Quotes), studentcare proposed undertaking a competitive evaluation process and the SU agreed. This strategy resulted in lower costs in the short term, allowing the SU to build up financial reserves to offset the inevitable cost increases.

A key strategy recommended by studentcare.net/works when contemplating a transition to a new insurer is to negotiate a 2 Year Premium Guarantee: to ensure optimum cost stability as the operational changes to the Plan and impact on claims are fully realized.

In combination, these strategies saved SU members over \$1 million dollars from 2012-2014. However, this is not a "magic bullet" that can be employed frequently. We are now coming to the end of a 2 Year Premium guarantee, and must begin the next phase of planning ahead.

After significant deliberation at 2 meetings, the Health & Dental Plan Committee unanimously decided to recommend this fee increase for 2 reasons:

- 1) To continue to build the Reserve Fund, but reduce the amount per student to mitigate cost impact due to higher premiums. This is a balanced approach, consistent with the long-term planning goals established during the original referendum and Plan implementation.
- 2) To prepare for even higher-than-projected Claims in 2014-15, due to the potential for new dental office or vision care provider to open in SUB. Should the SU agree to lease space in SUB Lower Level to a dental office, optometrist or paramedical practitioner, the increased awareness and access will lead to higher claims. For example, studentcare.net/works has analyzed the impact of dental offices on campus for other student unions and concluded that the impact on claims could be between 30% 50%.

Higher claims due to improved access isn't necessarily negative: if more students will be able to take advantage of their benefits because of a convenient location then that may be part of the Plan's purpose and mandate. However, higher claims will mean higher premiums in future years, and the HDPC recommends continued building of the reserve fund now to build capacity, and to spread out the potential fee increases in a measured, incremental way.

The Executive and HDPC will continue to meet with studentcare.net/works over the coming months to review their recommended strategies and best-practices for balancing the impact of health and dental providers as tenants.

### Introduction

Hello Council,

Sorry for the late report. It's been pretty ridiculous trying to catch up to everything, and I've got a big class project due tomorrow that is not anywhere near completion yet so hopefully I have your understanding. Without any further ado, I'll get right into it.

### The Premier's Resignation:

Obviously you've all heard about this by now, but the real question is how or if it has effect on us. The answer is an absolute yes, both in terms of what's happening now and what will be coming up for my successors term. While the Council of Alberta University Students' will continue meeting with MLA's (especially with our Lobby week starting on the 30<sup>th</sup>) it is highly unlikely that given the current circumstances the government will be looking to move on any of our issues.

While our Minister is now the Premier and has kept the Ministry of Advanced Education, these kinds of government decisions are going to be left to whoever the newly elected leader is. We as student leaders should continue to direct our ideas at MLA's in the meantime in hope they will take action after a new Premier has been elected, but right now all attention is turning towards the leadership contest.

I am optimistic that our new VP External will advocate to Leadership candidates and bring student attention towards it. The PC Party has determined that any PC member can vote, and therefore any person can vote so long as they have a PC membership. This will be a race that directly elects a new Premier, and if every student in Alberta voted it would likely decide the election. While that probably wouldn't happen, we can still have effect on its outcome.

### Meeting with Minister Lukaszuk:

Earlier last week Petros Kusmu, Navneet Khinda, Beverly Eastham and I all met with the Minster of Jobs, Skills, Training, and Labour Thomas Lukaszuk. During this meeting, one of the main topics was the recent budget and the Summer Temporary Employment Program. It appears as though funding has been made available for its revitalization, and combined with the Ministry of Advanced Education they would look to create a new and different system.

It largely sounds like this new employment program would focus more in meaningful employment than simply just employment. The old STEP program would fund a wide variety of jobs ranging from servers to charity workers. The new employment program would focus more on finding summer positions for students based on the degree they were taking. This will likely provide fewer jobs in the end, however will still ensure progress towards creating summer employment opportunities for students.

As I've been saying all year, I am optimistic now that we finally know a program will almost certainly be created moving forward we should be able to have a roundtable on the topic of student employment so that we can have actual input from institutions all across Alberta. Due to yet more government "shuffling" it is unlikely this



roundtable will occur during my term, but I am optimistic that my successor and the Council of Alberta University Students' will be able to see it done.

### Canadian Alliance of Students' Associations:

The Annual General Meetings of the Canadian Alliance of Students' Associations does not typically deal with that much policy, however we did see a few motions passed that were policy related. The one big one was related to how CASA presents its policies, and how we should develop our policies moving forward. In the end, representatives from across the country adopted a version that is similar to how Ontario's provincial students lobby organization. It would take a while to explain, so I will just provide you the link to their policy page. http://www.ousa.ca/policy/ Ultimately I think this was a good decision, and will move CASA in the direction of having more substantive policy briefs and information for its members.

There were also a number of policy updates and amendments, though no policy was altered dramatically. If you want further details on any of these we can set up an appointment to go over it. CASA made amendments to policies surrounding province of origin differential tuition, deferred maintenance, PSE in trade agreements, integration of student loans, condemnation of private for profit universities, mental health policy framework, youth unemployment, credit transferability, and a large discussion around commercialization of research that President Kusmu effectively killed because that's how he rolls.

Finally, there were also a number of changes proposed regarding CASA's membership requirements which I hope to briefly cover in my oral report as writing it out would confuse everyone, including me. Overall, CASA AGM was a good experience, and though the organization has been dealing with some struggles of late, it was great to see student leaders from all across the country do their best to improve the situation.

### **Council of Alberta University Students:**

So next Monday is the start of CAUS' lobby week in which we spend the majority of our time meeting with as many MLA's as possible. While I have yet to see the final list yet, it is likely that after our advocacy week we will have met with nearly all-82 MLA's in the province. If there are any left after that, I will make it a priority to try and sit down with them before the end of my term. CAUS will be advocating on our usual issues, mandatory non-instructional fee's, student financial aid, and funding for post secondary.

I would also like to state that the U of C VP External and Chair of CAUS was accepted to compete in "Red Bull: Can You Make It". Until he returns I am the "unofficial" acting Chair of CAUS and will be in that role for the entire advocacy week. Conner will return to his responsibilities as Chair when he returns home and I wish and his team luck in getting from London to Berlin.

### Additional Information:

Two small tidbits for you, the first being that President Kusmu and I are currently trying to set up a meeting with Mayor Iveson. It is unclear whether it will be the current Executive or incoming Executive that actually take the meeting. In addition, I will be attending one (and only one) government tuition working group meeting. I am thrilled that we finally have student representation on this committee, and look forward to throwing in my two cents before I'm out the door.
