We have restructured the management hierarchy to better suit the needs that we have seen in the last month or so. Both of our licensed operations have done well so far (through September), and both have better numbers than last year through the same period. Wireless access is being investigated in both places. More on that next time.

FSAG

Sat on the Food Services Advisory Group along with the president, our GM Bill Smith, VPSL Le, Councilor Campbell (Yes, we were very well represented), as well as a representative from the university and Aramark. Discussions were fruitful, more to come on that. As well, I will be sitting on the Health Sciences Advisory Group with Chris "Spring-roll" Le, which will discuss the health services fee, use of the health centre, etc.

Manager Meetings

I am scheduling meetings with each of our business and facilities senior management (going to be bi-weekly routine) to ensure good communication of their issues with exec. September was very hectic, so this should be a good chance to catch up and make sure that the rest of the year runs as smoothly as possible.

Investment Policy

I was just briefed on the policies that our investments are subject to. They are primarily in very secure, income-generating debentures (such as government bonds). With the current market conditions, I feel that this is a good place for them to be, and hence will not be making any large changes to their weighting at this time.

Retreat!

The executive is going on a full day retreat (same day as council is on), and this should be a good chance to re-evaluate our goals, how we are doing on all of them, and any problems that have arisen over the last couple weeks. Should be productive, and better be since there is little opportunity to do such things.
