- If the councillor accumulates two unexcused absences in a trimester, the councillor will be removed from council immediately following the second

unexcused absence.

- If the total voting membership of Stu	dents' Council drops below twenty, then a
by-election will be called in September	, October or January of that year.

# Report to Students' Council

# Audit Committee

2008-2009/AC/05

Dear Council:

First, I express my apologies for neglecting to submit any prior reports to council. Please refer to the Audit Committee's minutes for any additional information regarding previous meetings or feel free to contact me at any time for any information pertaining to the Audit Committee.

Two major points of interest to council:

1) At the September 24<sup>th</sup> meeting of the Audit Committee, representatives from Watson & Aberant, L.L.P, the external auditors of the University of Alberta Students' Union, presented the Audit Committee with the draft results of the annual audit. The committee received an explanation of the documents provided and could ask questions regarding particular details disclosed in each document. The committee shall review the audited financial statements of the Students' Union and the focus of this review shall be on ensuring congruencies between budgeted amounts and actual amounts, reasons for differences, and marked differences from year to year. Because of the detail and breadth of the audited financial statements, no less than two meetings will be devoted to this review process. If the audit passes the inspection of the committee, a motion shall be made to approve the audit.

Of particular interest or concern to the committee was the clean audit opinion prefacing the financial statements, the management recommendations offered, the variance analyses provided, the option of Watson & Aberant conducting the annual audit throughout the fiscal year (for a few days once every quarter) rather than all at once for several weeks in July/August, and the inclusion of non-financial information with the Students' Union financial statements—as in the style of an annual report.

I will be requesting that Watson & Aberant representatives present at the October 8<sup>th</sup>, 2008 meeting of the Audit Committee. It is a very favourable idea to have a second presentation after the committee's membership has been replenished from the current three (3) members to the maximum of five (5) members.

As a side note, I encourage all new councillors elected in the by-election to consider being nominated for Audit Committee—and that goes for all other councillors, as well!

2) The committee changed its standing orders regarding executive and staff credit card statement review. The Audit Committee will no longer be obligated by standing orders to review the statements for every monthly period, but instead will have the ability to request statement packages to be prepared at their discretion. The committee is still obligated to review at least one (1) statement package per trimester and any more will be at the discretion of the committee. The Audit Committee agreed this change would not negatively impact the objective of the previous processes of credit card statement review or the potential for increased erroneous and/or fraudulent usage of credit cards, but would allow for the committee to better allocate its time to other matters of importance.

Again, please refer to the minutes posted to the Students' Union website for additional information. I hope to regularly update council on the efforts of the Audit Committee. In the near future we will be reviewing submitted documentation from Dedicated Fee Units [Alberta Public Interest Research Group (APIRG); First Alberta Campus Radio Association (FACRA); Gateway Student Journalism Society (Gateway); and Student Legal Services of Edmonton (SLS)] for the purposes of fee disbursal, reviewing the departments of the S.U., discussing the role of Audit Committee as it relates to FMF/FAMF monitoring, and researching the potential for a Students' Union whistleblower policy.

## Council Report 08 – September 30, 2008 Kristen Flath, Vice President (Student Life)

Hello Council,

Here is an update on what has been happening the past couple of weeks.

**Student Engagement Proposal** – The University is still discussing our proposal. I will let you know if there are any developments.

Campus Law Review Committee (CLRC) – In CLRC this week, there was a debate regarding a proposal to give Associate Dean's guidelines to follow when disciplining a student. The proposal was previously passed through CLRC onto another committee, but was retracted when the Associate Dean's wanted more consultation. We will likely be starting up a working group to go over the proposal.

**U-Pass Advisory Group** – I met with ETS to discuss the feedback on the U-Pass, and any positives or negatives surrounding the program. The group is looking at doing a student survey to gain feedback for the next round of negotiations. The U-Pass is currently in its pilot stage and will likely come back as a referendum to students in 2010 to move from a pilot to an actual program.

**Campus Recreation** - I will be having a follow up meeting with campus rec to discuss program changes and how those have affected sports clubs. Please let me know if you have any feedback or know someone who does.

**Eco-Week** – October 6-10 will be Eco-Week, and we will be having events every day related to helping students become more environmentally conscious. For more information please come talk to me and keep your eyes out for the poster.

**Health Plan** – The committee has finished gathering the information it needs regarding health plan providers. We are bringing a motion to council that would allow us to enter into negotiations. I will provide a more extensive update at Council.

**Falcons** – The falcons are alive and well. And there are two of them! There was a baby abandoned by its parent in Red Deer, and so we have put it in with our pair. The babies will start fledging anytime, so hopefully that goes well.

The Exec spent a couple of days away with our new General Manager to go over what we are working on, any upcoming issues, and make sure we are on track in terms of organizational goals. The time away was a good chance to re-evaluate our issues and goals.
