#### **Programming**

We have started the initial planning of Campus Cup for November. We will also be looking into a musical for second semester and really building on Antifreeze. I will be doing Week of Welcome, Orientation, and Clubs Fair debriefs over the next two weeks. If you have any thoughts on any of these items please let me know so I can incorporate them into these discussions.

#### **Student Services**

We are making some changes to the Centre for Student Development staffing structure. Most notably we will be replacing the Vitamin A Co ordinator with a Co Curricular Record coordinator. We are also changing the management structure from 2 equal managers (Transition Programs and Orientation Managers) to a managers and assistant manager of the entire service.

I have been working with the manager and assistant manager of Infolink and our Senior Manager Student Services to facilitate an Infolink redesign. We have made a lot of progress and will be going to our marketing department to start mock up design creations over the next few weeks. We are also in discussions regarding moving the Peer Support Centre to the second floor of SUB to be closer to University Student Mental Health Services.

#### Residences

The new Residence Community Standards have been delayed going to Campus Law Review Committee as an item to be voted on. I have been meeting frequently with Residence Services administration to work on Residence Lease procedures, which are connected with the new Community Standards but not as a linked policy.

#### **Athletics Fees**

I have been doing a lot of reading and research on athletic fees and how they work. I will bring up these as a discussion item at Council of Student Affairs and hope to get the Athletics and Recreation Fee Advisory Committee started up soon. The administration and oversight of these fees is a bit unclear and I hope to put together a proposal to clean it up sometime this year.

#### **Alcohol Policy**

There are discussions going on regarding the mandate of the Alcohol Policy Review Committee as well as pubcrawls on campus. These will be ongoing for at least the first semester.

#### Council Outreach

On Monday I was out and about doing speaking to classes from 8:00am to 1:00pm, before I had to attend General Faculties Council at 2:00pm. Generally, I think the speaking and reminder of the Health & Dental Plan and Add/Drop Deadline were well received. I have spoke with a couple of you who did some speaking and I would be interested to know who else participated and what experience or feedback you received throughout the day.

I am also really excited at the prospect of a Council Townhall. I have a class scheduled at the same time but I really look forward to hearing how that goes.

#### **PAW Agreement**

I attended another PAW meeting to discuss our agreement with the University. Because this document will be significant for the next thirty years, we are working diligently to make sure that we get it right. Although the process has been time intensive, there is not much new to report. Just understand that it is taking up an increasing amount of my time and that we will bring it to Council as soon as it is presentable.



#### Sustainability Assessment

We had a really positive sustainability assessment meeting last week. We are now having weekly meetings to discuss the results and provide some context for the data collected to strengthen the document. I am very excited with the work that has been done thus far and I am looking forward to when we have a finished document to present to Council. I think the findings and recommendations of the assessment will put us in a great position to becoming a socially and environmentally responsible and accountable organization. Last Wednesday, the Committee had an orientation session and tour of SUB to get a better understanding of how the organization currently operates. Following his resignation, I asked Governor Turner to have the selection committee put forward another candidate from the original process. They have recommended to Council that Brennan Murphy be appointed to the committee and you will have an opportunity to vote on the appointment tonight.

#### **September By-Election Status**

The September By-elections were off to a rocky start predominantly due to a time shortage. Despite this, nomination packages were filed in a timely manner. Assuming that all positions with candidates are filled, there will be only two vacancies in Student Council, one in open studies and one in Science.

NOTE 1: Vacant positions left on Council for the 2010–11 term: Science (1), Open Studies (1).

NOTE 2: Vacant positions left on GFC for the 2010–11 term: Arts (1), Education (3), Native Studies (1), Nursing (2), Physical Education and Recreation (1).

#### Mistakes in the Nomination Package

The first incarnation of the nomination package stated that there was 1 open SC position in the Faculty of Nursing, and 0 in the Faculty of Science. The opposite was true. Subsequent nomination packages included the correction, and the previous nomination packages were corrected by hand.

#### **Rulings**

1.) I was approached by various parties as to whether the second Science Councilor vacancy (vacated by former councilor Cheung, early in September) can be filled. I ruled that it cannot, due to section 76 (1) of bylaw 2000.

#### 76. By-Election – General Faculties Council and Students' Council

(1) Where vacancies exist in positions filled under this bylaw on August 15 of any year, the C.R.O. shall call a by-election to take place in September or October of that year for all those positions vacant on August 15.

2.) President Dehod approached me on September 14th about extending the deadline of nominations in an attempt to fill vacant General Faculties Council seats. I had to rule that this was not possible due to section 76 (4) of bylaw 2000.

#### 76. By-Election – General Faculties Council and Students' Council

. . .

(4) The deadline for the nomination of candidates in any by-election shall be determined and announced by the C.R.O. at the same time as the date of the by-election is announced, such deadline occurring not less than nine (9) days prior to the Election.

#### **Polling Stations**

There will be four polling stations for the by-elections.

SUB – Main Floor, beside SUBmart CAB – Main Floor, next to Infolink Booth Van Vliet – In the hallway leading to the Equipment & Change Room Education Buildings North – North/South Corridor, near the cafeteria.
