SUNDAY/CHRISTENSEN MOVE to create the Aboriginal Relations and Reconciliation ad hoc committee, on the recommendation of Bylaw Committee, with the following terms of reference:

- Mandate: The Aboriginal Relations and Reconciliation Committee
 - a. Shall make recommendations to Students' Council on the implementation of the Truth and Reconciliation Commission's Calls to Action:
 - Shall ensure adequate consultation, as defined by this committee, is completed by Students' Council in regards to Aboriginal students at the University of Alberta;
 - c. Shall assist, after consultation, Students' Council in identifying Aboriginal priorities;
 - d. Shall develop strategies on the respectful implementation of Indigenous knowledges and teachings;
 - e. Shall foster collaboration between the Students' Council and Aboriginal communities;
 - f. Shall work with Students' Council Standing Committees in implementing the Truth and Reconciliation Commission's *Calls to Action* and representing and consulting Aboriginal students.
 - g. Shall work with the Executive Committee of the Students'
 Union in implementing the Truth and Reconciliation
 Commission's Calls to Action, the Truth and
 Reconciliation Commission Political Policy and
 representing and consulting Aboriginal students.
 - h. Shall facilitate cultural sensitivity training for Students' Council, if necessary.
 - Shall compile a report on the representation and consultation of Aboriginal students as well as relevant advocacy work done by Students' Council, including the Executive Committee.

- j. Shall establish the framework for a Standing Committee that, in addition to the above mandate, will make recommendations on the following, by September 1, 2017:
 - i. Committee Membership: voting and non-voting;
 - ii. Addition of an Elder(s) and Oskapew to this Committee;
 - iii. Compilation of all relevant work done by Students' Council directly affecting Aboriginal students over the past 10 years;
 - iv. Requirement for Committee members to be trained in Aboriginal cultural sensitivity and inclusivity.
- k. Shall expire when the above Standing Committee is established by Students' Council.
- 2. Membership of this committee will be nine (9).
 - a. Five (5) members of Students' Council;
 - b. Two (2) members of the Executive Committee, as appointed by the Executive Committee;
 - c. Two (2) executive members of the Aboriginal Student Council as voting members.

LETTER OF UNDERSTANDING

THE STUDENTS' UNION, THE UNIVERSITY OF ALBERTA (SU)

And

THE GRADUATE STUDENTS' ASSOCIATION OF THE UNIVERSITY OF ALBERTA (GSA)

WHEREAS:

- A. Both parties recognize the importance of Residence Associations in supporting and representing students living in residence;
- B. Any specific residence may contain both graduate and undergraduate students;
- C. Individual residence associations may determine that there is a need for fees to supplement and support programming and representative efforts;
- D. The SU and the GSA have authority under the Post-Secondary Learning Act to levy membership fees;
- E. Both parties agree that all residents benefit from the services provided by Residence Associations, and therefore both undergraduate and graduate students should be assessed equivalent residence association fees;
- F. Residence Association fees should generally be supported by students as demonstrated democratically;
- G. Both parties recognize the need for efficient, fair, and transparent administration of any residence fees,

The parties agree as follows:

- 1. The SU and the GSA shall pursue approval according to their respective governance frameworks to assess fees on students in particular residences according to a shared fee schedule;
- 2. Continuation of any fees approved in 2017 will be subject to a referendum of residents in the affected residences, to be held no later than April, 2018;
- 3. The Students' Union shall administer fee collections for Residence Associations in trust, shall disburse funds collected from undergraduate students in accordance with its bylaws, and shall disburse funds collected from graduate students only with the approval of the GSA Board;
- 4. The Students' Union Executive commits to pursue amendment of its bylaws and standing orders to permit proportional representation from the GSA on the SU's Audit Committee, which would then approve disbursals of residence association fees. The Students' Union further commits that this and any future amendments to SU bylaws that affect the matters covered in this letter of understanding will be considered only after discussion with the GSA.
- 5. If item 4 above is completed and both parties agree, the method of disbursement of funds outlined in item 3 will be replaced by the method outlined in the new bylaws created at part of

item 4. Should the GSA wish to rescind its agreement with item 4, the process for disbursement will revert to the process outlined in item 3.

Hi Council,

Elections have taken campus by storm, as we've seen many students come out to forums, ask questions, and become involved in the democratic process here. I hope the trend continues for the upcoming Council elections, because of the important work you all do. I'm submitting this report before the results of the Executive and Board elections are announced, but congratulations and thank you to everyone who participated as a candidate, volunteer, or engaged voter.

VP Sandare and I will be away for this Council meeting, as we have a CASA AGM in sunny Wolfville, Nova Scotia.

Here is an update on my activities since we last met:

1. Student Groups

VP Ghossein, GM Dumouchel and I presented our feedback to the Dean of Students office on the draft Student Groups policy suite. We are working with the Dean of Students to provide more clarity for the type of risks they consider when recognizing student groups on campus, as well as ensuring that decision review panels are as neutral as possible, possibly through an appeals committee.

2. Lister and PLH Meal Plan

The Lister meal plan, which is a variant on the old declining balance program, has been approved by BFPC and will be coming to Board for final approval this coming Friday. The declining balance aspect of the plan gives students sufficient flexibility in my opinion, and I'm hopeful we're able to extend the operating hours later relative to the old program.

The Peter Lougheed Hall meal plan, which was an anytime dining model, was approved by BFPC. I voted against the proposal, as there hadn't been sufficient consultation with students and not enough flexibility was provided. I also am very concerned that the occupancy rates for the PLH will be lower than the projected 95%, creating even larger pressure on the already strained university budget.

3. CASA

I attended my first Board meeting for CASA, which had a very packed agenda. Key items approved here were the plenary agendas for our AGM next week, as well as a partnership with UEQ (Union Étudiante du Québec). This would give CASA the ability to represent Quebec students, while giving UEQ more legitimacy on federal advocacy for Quebec students.

4. Academic Governance



I attended the Committee on the Learning Environment on behalf of VP Banister, and gave an update on the activities of the teaching stream subcommittee. A report is ready for GFC CLE approval, and then will hopefully be presented to GFC Exec with a recommendation that the research obtained here is acted upon.

I also attended GFC Exec on behalf of VP Banister, where we approved the draft agenda for the upcoming GFC meeting.

I also attended the Academic Planning Committee's meeting, which received a few reports from other bodies on campus. We are awaiting the results of the provincial budget on March 16th, as well as the federal budget March 22nd.

5. Non-Academic Governance

I attended a meeting of the Residence Advisory Committee where a discussion point was developing consequences for students who opt-out of their residence association fee payments. I also attended a meeting of the Student Accessibility Services Advisory committee, where accessible washrooms was a prominent topic. Lastly, the VP Research search committee met to discuss the search process.

6. CAUS

A subgroup of CAUS met to discuss our contingency plans in case of a shortfall in mental health funding, that I attended on behalf of VP Sandare. We're currently writing letters to the Ministers of Health, Advanced Education and Finance about the importance of this funding in advance of the budget being released.

7. Interviews

I was present for the funding announcement by Minister Sohi for the Canadian Foundation for Innovation, supporting 14 research projects here at the University of Alberta. The Gateway asked for comment on some graffiti that has been spotted around campus, as this isn't the first time we have seen graffiti here. Finally, a visiting student from Germany involved with her campus SU interviewed me on the SU's role with the government and university, to take notes back to her colleagues.

8. Presence and Relevancy

I had a great time speaking at the High School Model United Nations organized by some talented U of A students. I also was invited to speak to students in the Emerging Leaders Program alongside a few other leaders in the Edmonton community.

9. U-Pass

Running the U-Pass campaign has been a pleasure, thanks to the lovely poster design by Nelson Cao and website design by Sai Vemula. Most the feedback I've received is on improving the length and frequency of service at Sherwood Park, as well as expanding the conditions for opting out based on



your residence's proximity to campus. I believe both these items can be addressed by future executives and the City of Edmonton in advance of the next referendum, and hopefully implemented.

(I mean, VP Paches has a great track record of getting good deals with the City of Edmonton...)

Dear Students' Council:

The following written report has been submitted in compliance with the now obsolete requirements formerly available in Bylaw 100, Section 16.

1) Decisions of Bylaw Committee

After extensive discussion at the emergency meeting of Bylaw Committee held on March 7, 2017 the committee made numerous decisions with regard to Bill #13 - Creation of the *Truth and Reconciliation Commission Implementation Committee*.

Bill #13 was originally presented to Students' Council on February 28, 2017 by Councillor Nathan Sunday. Concerns were raised regarding the exact nature of the committee, its title, mandate, and function, among other things. As such, the Bill was referred to Bylaw Committee with overwhelming support of Students' Council.

At the beginning of the meeting of Bylaw Committee on March 7 the committee was generally in favor of the creation of this as a standing committee, with slight modification to the name, mandate and composition, as listed on the Students' Council Order Paper for February 28. However, as discussion went on, it became clear that not all aspects of the committee had been fully elucidated or realized. At the meeting, Councillor Sunday proposed changing the Aboriginal Students' Council seat to a voting seat, adding an Elder to the committee with paid honoraria and providing funding to the committee to travel and consult with community and other campuses.

Considering these new requests, the committee decided that the scope of these changes were far beyond the mandate of Bylaw Committee alone and of the referral motion SC-2016-21/8a. As such, the committee decided to indefinitely defer the first reading of Bill #13, and recommend these points be discussed at Council Administration Committee and Finance Committee.

The committee then decided to create the temporary *Aboriginal Relations and Reconciliation Ad hoc Committee* as a solution to the present logistical quagmire. The structure and mandate of this *Ad hoc* committee closely matches that of the original standing committee proposed in Bill #13, but allow for non-Students' Council voting membership. As part of this *Ad hoc* committee's

mandate, it will clarify the final membership and structure of a future standing committee of Students' Council, including budgetary considerations and changes to SU institutional customs.

Finally, Bill #9 - SIEF Reform is still before the Executive Committee and has not yet been presented to Bylaw Committee. The executive will continue to work within the SU establishment to hash out a more rigorous and finalized plan before presenting it in the indefinite future.

The final meeting of Bylaw Committee is on Wednesday, April 5, 2017 @ 6:00 PM.

2) Recommendations of Bylaw Committee

Bylaw Committee recommends Students' Council implement the *Aboriginal Relations and Reconciliation Ad hoc Committee* with the terms of reference listed on the Order Paper.

Bylaw Committee recommends the Council Administration Committee discuss the implications, practicality and legality of allowing standing committees to include non-Students' Council members (*i.e.* students-at-large) to sit as voting members.

Bylaw Committee recommends Finance Committee discuss the feasibility of honoraria and travel allowances for members and committees, particularly in the situation of bringing Elders and community outreach.

3) Bylaw Committee Standing Orders

There have been no changes to Bylaw Committee's standing orders since May 5, 2016.

4) Summary of Motions

As the list of motions is no longer required under Bylaw 100(16), they are not included here. They will be included on Discover Governance's running list, available on the Order Paper.

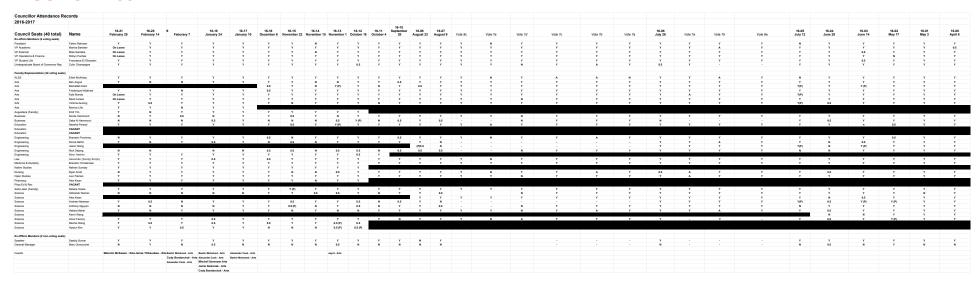

First Principles

- 1. The Truth and Reconciliation Commission (TRC) was a fundamental component of the Indian Residential Schools Settlement Agreement. The mandate of the TRC was to inform all Canadians of the atrocities which took place in Indian Residential Schools. Residential Schools were government-sponsored boarding schools established in the mid 19th century, with the sole purpose of the acculturation and complete assimilation of Aboriginal children. As Residential Schools were compulsory, children were forcibly taken from their parents and frequently subjected to physical, emotional, and sexual abuse. The TRC's main goal was to guide both Aboriginal Peoples and Canada-at-large along the path towards reconciliation and healing. In its final report, the TRC listed a set of *Calls for Action*, a set of principles to guide in the journey of reconciliation.
- 2. The purpose of this committee will be to foster healthy, respectful relationships with Aboriginal students on Campus. Moreover, in further implementing elements of the TRC, Students' Council creates both accountability to Aboriginal students and in carrying the spirit of reconciliation. As many Aboriginal students do not feel the Students' Union represents—or is for—them, the creation and work of this committee would be an effective first-step in assuaging these hesitations.
- 3. The Truth and Reconciliation Implementation Committee will have the following mandate:
 - a. Shall make recommendations to Students' Council on the implementation of the Truth and Reconciliation Commission's Calls to Action;
 - Shall ensure adequate consultation is completed by Students'
 Council in regards to Aboriginal students on Campus;
 - c. Assist, after consultation, Students' Council in identifying Aboriginal priorities;
 - d. Develop strategies on the respectful implementation of Indigenous knowledges and teachings;

- e. Foster collaboration between the Students' Council and Aboriginal communities;
- f. Review Students' Council Standing Committees and report on their progress in implementing the Truth and Reconciliation Commission's *Calls to Action* and how, if they have, represented and consulted Aboriginal Students.
- g. Periodically review the Executive Committee of the Students' Union in relation to the Truth and Reconciliation Commission's Calls to Action and the Truth and Reconciliation Political Policy.
- h. Facilitate, if necessary, cultural sensitivity training for Students' Council.
- 4. Membership of this committee will be eight (8).
 - a. Five (5) members of Students' Council;
 - b. The Vice-President (Academic);
 - c. The Vice-President (Student Life);
 - d. An Executive member of the Aboriginal Student Council as a non-voting member.
- 5. Bylaw 100 shall be amended to implement the above changes, including general committee requirements as required for all committees.
