A Case for Creating a University of Alberta Charter of Student Rights and Responsibilities

The Issue




- Students of all demographics and years of study tend to be unfamiliar with the substance of central UAlberta policy documents, such as the Code of Student Behaviour and the Grading Policy and Procedure.
- Many students do not know how to access information on how to make an appeal when they are accused of breaking a UAlberta policy.

The Statistics

- In an exploratory study, the Students' Union collected 1721 responses to understand students' perception, experience, and awareness of their rights and responsibilities.
- 58% of respondents indicated they "did not know much" or "did not know anything at all" about their rights and responsibilities, and very few respondents were confident they knew a lot.
- 10% of students were unaware that any of these documents existed.


"Information about university policies and my rights as a student are easy to find"

I felt especially powerless because I was going up against the Dean of my faculty who had complete control over what was going to happen to me. I felt weak and vulnerable. I would have liked to know about other options and all of the potential outcomes.

At times I have wanted to appeal grades but had difficulty. The pathway of escalation is confusing, especially in courses with TAs, instructors, coordinators, etc. It would be nice if instructors provided the pathway of escalation as well as instructions for each stage to make it easier for students. I don't have time during the semester to figure that all out.

Our Solution



- Endorse the creation of a Charter of Student Rights & Responsibilities.
- This Charter will serve as a consolidated document of all of a student's rights and responsibilities at a university. This process puts student rights and responsibilities front-of-mind for both students and other members of the university community, creating a culture of improved clarity and accountability.

What would be included in this Charter?

- A preamble to set the tone of the document.
- Consolidation of academic rights, procedural rights, and fundamental rights that currently exist in the University of Alberta Policies and Procedures Online (UAPPOL).

A Draft Preamble

Clear expectations and standards can equip students to avoid mistakes, misunderstandings, and serious problems during their time at the University of Alberta. This document is meant to serve as a guide for students and create clarity about the authoritative resources that explain their rights and responsibilities. Within the scope of the University of Alberta's authority, its diverse policies and procedures are the authoritative resources that affirm students' rights and responsibilities. As those rights and responsibilities are spread throughout many policy documents, this document will serve as a proactive resource to help students avoid problems, and a reactive resource to help them navigate appeals and disciplinary processes in ways that produce the fairest possible results.
