The University of Alberta and the University of Alberta Students' Union occupy Indigenous land in amiskwacîswâskahikan (Beaver Hills House), on Treaty 6 territory. From time immemorial, the banks along the river valley have been known as the Pehonan, a meeting place for the nêhiyawak (Cree), the Niitsítapi (Blackfoot), Métis, Dënesųliné (Dene), Ojibway/Saulteaux/Anishinaabe, Haudenosaunee and others. The University, the Students' Union and much of the city are located on the unlawfully stolen land of the forcibly removed Papaschase Cree.

We acknowledge that sharing this land gives each of us the responsibility to research the historic contexts of Treaty 6, to reflect on our personal relationships to the land, the Nations we've named, and to our roles in upholding justice on this territory. Since they began, the Students' Union and the University have benefited from historic and ongoing dispossession of land and resources from Indigenous Peoples. As a result, it is our responsibility to seek the restitution of this land and its resources. Finally, we seek to do better by working to make our learning, research, and governance align with the histories, languages, teachings, and cultures of First Nations, Métis, and Inuit Peoples in the land presently occupied by the Canadian state.

We encourage critical reflection by asking the following question. In relation to the territory on which you are situated, what role do you play in strengthening the resistance and resurgence of Indigenous students within your communities?

Inclusive Access .org

What is Inclusive Access?

Inclusive Access is a textbook sales model that adds the cost of digital course content into students' tuition and fees.

How does Inclusive Access work?

- Based on an agreement between an institution, a bookstore, and publishers.
- Digital content is delivered to students by the first day, typically through a LMS.
- In the U.S., Students have a period to "opt out" under federal regulations.
- The cost is billed to students' tuition and fee bill or bursar account.
- After the course ends, students typically lose access to the content.

Inclusive Access

- Digital access is available by day one and students are directly billed for the cost later.
- Print rental option <u>may</u> be available at additional cost.
- Full access typically <u>expires</u> after the course ends.
- "All rights reserved" copyright prevents unauthorized use.

OER

- Digital access is available by day one at no cost to students.
 Access is <u>free forever</u>.
- Students <u>can</u> choose low cost print option if desired.
- Students <u>retain</u> access to materials forever.
- Openly licensed so faculty can adapt materials to local needs.

Inclusive Access Models

1. Course-by-Course

Students in participating courses are charged the cost of the specific materials they have been assigned.

2. Flat Fee / "Equitable Access"


All students are charged a flat amount based on how many units or credit hours they are taking, no matter what their specific materials cost.

Course-by-Course

- Students are billed the actual cost of their materials
- Opt-out is typically on a courseby-course basis
- Institution can negotiate prices with multiple vendors
- More often voluntary for faculty
- OER always free for students

Flat Fee / "EA"

- Students pay a flat fee regardless of what the actual cost is
- Opt-out is typically all or nothing (all courses or no courses)
- Often outsourced to one vendor
- All faculty must participate
- Students may get charged even if faculty assign OER



Refuting IA saves students money

- Prices may be less, but students get less (short-term subscription)
- Savings from switching from print to digital are moot because students can already choose digital
- "Below market rates" are based on publisher prices, not the cheaper secondary market students rely on
- Discount off of publisher list prices are meaningless if they resume historical price increases

Refuting IA is equitable

- Savings are mostly for students who would normally buy an expensive option. Students who rely on used books, borrowing, etc. can actually pay more.
- Day one access at a fixed cost is equal but not equitable.
- Switching to digital introduces new barriers, including internet access, device age, and accommodations.

Refuting IA offers options

- Opt-out processes are often complex and rarely promoted to students proactively
- Opting out isn't always an option when materials include online homework
- Offline reading and long-term retention is limited
- Offers of print "upgrades" are limited

Questions to ask Inclusive Access vendors


- What is the methodology used to calculate advertised savings?
- How do the prices compare to the current used book/rental market?
- How long are the prices guaranteed?
- Is there peer-reviewed research to back up student outcomes claims?
- Does your company monetize student data?

Thinking bigger about course materials

- Make decisions that align the institution's interests with those of students not the textbook industry
- Consider the market dynamics and long term implications, rather than focusing only on procurement
- Lean into open educational resources as part of your sustainable digital infrastructure

What can you do?

- Be proactive. Make sure your admin, faculty, students are aware of the OER initiative on campus and why it has an impact
- Ask questions. Challenge your campus to thoroughly examine the legal, financial, and ethical implications of new models like Inclusive Access.
- Be rigorous. Ensure all claims about benefits and savings are backed up by evidence, including research and numbers.
- Center equity. Put student needs and voices at the center of the conversation – there is always time to consult and listen.



- Student pushback / mobilization
- Calls for more rigorous study or review
- Questions about overhead and margins
- Questions about fee authorization
- Concerns over student data privacy
- Examine relevant governmental regulations or institutional policies

for

- Exempt courses using 100% OER or zero-cost materials from the fee. Don't undo your progress!
- Take a hard look at the ethics of accepting a sales commission on the fee. (Or commit it to funding OER.)
- Use actual student spending data to verify the flat fee is a better deal for students.

Re: Speaker's Report – Spring/Summer Trimester

Dear Council:

Happy last meeting of the trimester! It has been such a pleasure to work with and get to know all of you. Here's an overview of what I've been doing for the last few months and what I'm expecting to happen in the next trimester.

Spring/Summer Trimester Overview

- *CSJ/Augustana Meetings:* Have held a range of meetings with stakeholders including AUFSJ, ASA, CAC, and Council representatives for CSJ and Augustana. The meeting dates have been set for October 14 (Augustana) and November 4 (CSJ). As I write this report, we are beginning to hammer out content and an agenda for each retreat.
- *Chairs Support*: I have had the pleasure of meeting with Council's committee chairs bi-weekly to support planning and time management for the year.
- *Ballot Voting Review*: I am reviewing how we conduct ballot voting (used for committee appointments, scholarship selection, etc.) to determine if we can find a more efficient way to run that type of voting and train other staff members to assist with counting.
- *Speaker Training Materials*: I have started the planning process to create formal training/resource materials for future Speakers.
- *General Administration:* Council Eligibility checks were completed for Spring/Summer with no concerns being raised; administering the Council Scholarship process; completing attendance checks and communicating requirements to members.
- *Studying/Professional Development*: I am currently studying to take my exam for the Registered Parliamentarian credential and I am concurrently exploring best practices in facilitating Council's governance. An example of such a practice that may be useful for Council is to use breakout groups to facilitate discussion on contentious topics.

Coming Up – Fall and Winter Trimesters

- *Continuing Work:* The CSJ/Augustana retreats, Speaker Training Materials, and Professional Development work will continue over the next two trimesters.
- *Council Feedback:* Given the importance of team culture this year, I will be talking to the CAC Chair + Executives regarding ways to check-in with Council as a whole in the Fall Trimester. We will also have a sharing circle exercise soon which will be a good opportunity for reflection.

- FAMF/DFU Preparations: November January is particularly busy for Council because
 we will be considering referendum and plebiscite questions for fees collected by the SU.
 Staff have begun to compile a list of likely proposals coming to Council and we will be
 working to both support groups proposing/renewing fees and working towards a smooth
 process.
- *Council Debate/Discussion Structure*: Given Council's reduced size and the types of debate that commonly happen at Council, I will be asking CAC to review how discussion is structured at our meetings.
- Robert's Rules/Governance Training: As requested at GovCamp, I'll be developing a training session on parliamentary procedure and related governance practices for Fall Trimester.

The University of Alberta and the University of Alberta Students' Union occupy Indigenous land in amiskwacîswâskahikan (Beaver Hills House), on Treaty 6 territory. From time immemorial, the banks along the river valley have been known as the Pehonan, a meeting place for the nêhiyawak (Cree), the Niitsítapi (Blackfoot), Métis, Dënesųliné (Dene), Ojibway/Saulteaux/Anishinaabe, Haudenosaunee and others. The University, the Students' Union and much of the city are located on the unlawfully stolen land of the forcibly removed Papaschase Cree.

We acknowledge that sharing this land gives each of us the responsibility to research the historic contexts of Treaty 6, to reflect on our personal relationships to the land, the Nations we've named, and to our roles in upholding justice on this territory. Since they began, the Students' Union and the University have benefited from historic and ongoing dispossession of land and resources from Indigenous Peoples. As a result, it is our responsibility to seek the restitution of this land and its resources. Finally, we seek to do better by working to make our learning, research, and governance align with the histories, languages, teachings, and cultures of First Nations, Métis, and Inuit Peoples in the land presently occupied by the Canadian state.

We encourage critical reflection by asking the following question. In relation to the territory on which you are situated, what role do you play in strengthening the resistance and resurgence of Indigenous students within your communities?
