The University of Alberta and the University of Alberta Students' Union occupy Indigenous land in amiskwacîswâskahikan (Beaver Hills House), on Treaty 6 territory. From time immemorial, the banks along the river valley have been known as the Pehonan, a meeting place for the nêhiyawak (Cree), the Niitsítapi (Blackfoot), Métis, Dënesųłiné (Dene), Ojibway/Saulteaux/Anishinaabe, Haudenosaunee and others. The University, the Students' Union and much of the city are located on the unlawfully stolen land of the forcibly removed Papaschase Cree.

We acknowledge that sharing this land gives each of us the responsibility to research the historic contexts of Treaty 6, to reflect on our personal relationships to the land, the Nations we've named, and to our roles in upholding justice on this territory. Since they began, the Students' Union and the University have benefited from historic and ongoing dispossession of land and resources from Indigenous Peoples. As a result, it is our responsibility to seek the restitution of this land and its resources. Finally, we seek to do better by working to make our learning, research, and governance align with the histories, languages, teachings, and cultures of First Nations, Métis, and Inuit Peoples in the land presently occupied by the Canadian state.

We encourage critical reflection by asking the following question. In relation to the territory on which you are situated, what role do you play in strengthening the resistance and resurgence of Indigenous students within your communities?

#### Purpose

To allow The Landing to add their DFU referendum question to the Winter 2024 ballots without conducting the petition process

#### **Executive Summary**

The Landing is a support service at the University of Alberta main campus that offers support for 2SLGBTQ+ students began as an independent DFU when launched in 2014 and was subsequently absorbed as an SU service in 2018. Renewed in 2020 for a 5-year term, The Landing is not up for its renewal plebiscite until 2025, however have put forth a proposal to amend the DFU fee early which you might remember from their presentation in November and the work Bylaw Committee undertook to draft and approve the ballot question.

To initiate a referendum, a DFU would ordinarily require a petition containing signatures from 15% of the current members or approximately 5361 students as per Bylaw 320. Back in the Fall term, leadership of the Landing have expressed doubts about being able to gather the required signatures given their occupational capacity with its small volunteer base and even smaller staff complement. They had expressed interest in requesting that Students' Council waive that petition requirement for them and allow

their referendum to proceed as per Bylaw 6100.

#### Purpose

To allow the Gateway Student Journalism Fund to add their DFU referendum question to the Winter 2024 ballots without conducting the petition process

#### **Executive Summary**

The Gateway, found in 1910, is the official student media outlet at the University of Alberta and is overseen by the Gateway Student Journalism Society. From its inception until 2002, the Gateway operated as a department of the Students' Union before running a successful DFU referendum and seceding to become an independent operation.

In 2020 - one year prior to their regular renewal plebiscite year - the GSJS ran a referendum to increase the amount of their DFU from \$3.54 to \$5.50 per semester which was unsuccessful. The following year, they held their regularly scheduled renewal plebiscite in 2021 which was also unsuccessful. Facing the prospect of an unsuccessful renewal referendum the following year, the GSJS and Students' Council authorized a joint resolution to cease collection of the Gateway Student Journalism Fund on April 13, 2021 (see motion 2020-26/7b).

With finances dwindling and the future of the 114-year old organization now in doubt, the GSJS has moved forward with trying to reintroduce their DFU. Facing similar operational capacity concerns as The Landing with a smaller team of staff and volunteers than in their heyday, GSJS leadership had requested that Students' Council waive their DFU petition requirements which until our recent bylaw amendments was not permitted. With that option now being available to them, this motion is being put forward for that reason.

# Executive Reports

# **Council Report #16**

#### Hi Council!

Below is an overview of the executive committee's activities this past month.

## Christian Fotang | President

#### **CAUS Counterparts**

Last week, Chris, Michael, Pedro, and I were in Calgary for another Council of Alberta University Students' counterparts hosted by the Students' Association of Mount Royal University (SAMRU). Similar to past counterparts, these conferences provide an opportunity for schools to connect, further collaborate, and provide each other updates on advocacy initiatives being undertaken on our various campuses. During our time, we were able to engage in conversations surrounding CAUS' advocacy and internal priorities for the remainder of the term. Breakout sessions for respective portfolios ignited conversations amongst the Presidents on our varying discussions with our respective administrations on tuition proposals. As usual, it was great to put together a picture of what actions were being taken across the province. The conference wrapped up with a professional development session on media training led by our External Relations coordinator.

#### **Council of Student Affairs**

The Council of Student Affairs (CoSA) met last Thursday to discuss items such as updates on the tuition and MNIF proposals, an overview of the undergraduate and graduate enrollment report, updates on the foundations' pathway program, the EDI action plan, and updates on SGBV training modules. With respect to undergraduate enrollment, I asked the University administration what impact they saw the recent announcement on international student caps having on future enrollment. The response was that, while specific information surrounding what the visa allocations per province was still needed, they suspected that Alberta wouldn't be targeted and could potentially see it being rewarded more seats. However, without official data, it would still be speculation. They did acknowledge that continued geopolitical tensions between China and Canada and India and Canada could have an effect on international student enrollment, especially in regards to graduate programs.

#### **BoG/GFC/Senate Joint Summit**

Last Friday, Pedro, Michael, Chris and I attended the BoG/GFC/Senate Joint Summit. This summit included a focused discussion on the University's People Strategy. It explored themes of ways to provide better support in career trajectory for staff as well as how the University can improve its engagement and consultation approaches within the community. It was great to hear from Senate, GFC and BoG members alike about ways we can constantly strive to improve and ensure this institution fosters a space that allows people of all backgrounds to succeed.

## Pedro Almeida | Vice-President Academic

#### ZTC announcement from MRU

Earlier on I had a chance to speak a bit with Tala, the Vice-President (Academic) of the Students' Association of Mount Royal University (SAMRU) at the CAUS Counterparts, where she informed me that she had some news on open education. Tala has since reached out with some great news. I asked if it would be possible to share the news with students here at the University of Alberta, and she said yes. For context, this email and news comes after the UASU's Position on the Academic Materials Program document (referenced as the UASU Report) was shared with SAMRU. A portion of her email read as follows:

I have some great news to share from MRU's Library and the Registrar's Office. The Library recently informed me that, partly due to our joint advocacy efforts and the invaluable insights from the UASU report, MRU is moving forward with the implementation of a Zero Textbook Cost label for select courses in the Fall 2024 schedule. This is a significant step forward in our pursuit of textbook affordability.

The Library and the Registrar's Office are currently working on a pilot program. The development of this program is a clear reflection of the impact that our collaborative work and the insights from "The UASU's Position on the Academic Materials Program" have had.



I am super proud to have been able to help the SAMRU team in furthering open education at their institution!

#### Faculty Association Offices

Over the past few weeks, I have been working quite closely with some of the Faculty Associations to support them as changes in facilities have caused certain concerns in terms of the office space. I have communicated with administrators from different faculties to ensure that student space for Faculty Associations are prioritized as things get shuffled around. In addition, the Facilities & Operations team has indicated that further consultation will be happening for a policy governing space management at a recent meeting of the Committee on the Learning Environment. I have followed up with that department to set up opportunities for them to engage with the Faculty Associations, to ensure that they are included in the plans moving forward.

#### Academic Integrity Policy Suite updates

In previous reports, I mentioned how the Academic Integrity Policy Suite has been a priority. As a quick update to Council, I am happy to let you know that the Suite has completed its main consultation phase, it is expected to be coming for approval later this term. I am also happy to report that the person leading this project has confirmed that the Suite will be adapted to include two areas of priority that I had highlighted to the team. There should be language that indicates the University will make its best effort to allow the appeal process to be able to occur in French for CSJ students. In addition, the Suite will ensure that Faculty Decision-Makers have to justify choosing to approach potential academic misconduct cases with the disciplinary route instead of the non-disciplinary route. This is awesome to see, and I am very hopeful that once the Suite is approved, it will be a significant improvement from the Code of Student Behaviour, improving the experience of students at the University of Alberta for years to come!

## Leviathan Q. Flaman Esq. | Vice-President Operations & Finance

#### Health & Dental Insurance while on Leave of Absence

A Juris Doctor student in the Faculty of Law recently reached out to us over issues they were facing with their Health & Dental insurance while on a faculty-approved leave of absence. When approved for their leave of absence, the student was under the impression they would maintain their insurance coverage but only found out after the fact that they did not. They sought services and filed for a claim for reimbursement which ended up not being covered leading to an expensive medical bill after which they reached out to Studentcare and their Dean's office attempting to find a resolution.



We had received the email chain between the student and their Dean's office from the Office of the Registrar. At our next scheduled meeting with the Registrar's Office, we raised the students' concerns and put forth a solution with a plan of action. The Registrar's Office seemed amenable to the Proposal and thus work was begun towards that solution; not just for the student in question but for any students in the future that may face similar circumstances.

#### Spring 2024 Convocation Relocated

A student reached out recently expressing disappointment with the decision to hold the Spring 2024 convocation ceremony in the <u>Butterdome</u> rather than the Northern Alberta Jubilee Auditorium where it is ordinarily held. Over the course of the summer, the Jubilee Auditorium is scheduled to be renovated which is why the ceremony can not be held there this year.

After reaching out to the Office of the Senate as well as the Convocations & Ceremonies Office, I was informed that several alternate venues were explored; including the Edmonton Convention Center, the Edmonton EXPO Center, and even Rogers Place. Considerations in choosing an alternate venue included size, cost, and availability. But ultimately it was the Butterdome that was decided on to host the ceremony this spring.

It seems unlikely for the ceremony to be relocated, therefore it is important that we take steps to better understand why some students are concerned about the ceremony being held in the Butterdome, or what they are losing by not graduating in the Jubilee Auditorium. The answers to these questions can help the planning team, including the Standing Committee on Convocation, with their preparations for the spring ceremony.

#### **APSN Mental Health Discussion**

On Friday January 19th myself, the Council of Alberta University Students' Vice Chair, and the CAUS Executive Director attended an opening conversation around shared mental health priorities with members of Alberta Post Secondary Networks' board. Alongside the Alberta Student Executive Council's leadership team, we had the opportunity to discuss the gaps we have identified within the post secondary mental health system and answer questions from the board of APSN. Given that their board is composed of PSI Presidents from across the



province, it was an important opportunity to speak directly with key on-campus decision makers who are also the drivers behind external advocacy.

#### **CAUS Counterparts**

Last week was our Calgary counterparts conference put on the Council of Alberta University Students. While we were there, we got a chance to work with our provincial partners on developing comprehensive strategies around housing and transitioning our priorities to next year. Always a pleasure to be with my counterparts from across Alberta joined in common cause.

#### Alberta Primetime Appearance

On Thursday January 25th I had the great honor of appearing on CTV's Alberta Prime Time for a seven minute in-studio conversation with Michael Higgins on the recently announced cap on new international student visas. We were able to discuss Alberta's need for international talent, our misgivings about blaming international students for a housing crisis that they didn't create, and the need for expanded work hours for international students. ## Michael Griffiths | Vice-President Student Life

#### **University of Alberta Sexual Assault Centre**

Recently, we have had many conversations with the University about the Sexual Assault Centre and the unmet needs of students. We hear students when they say that the centre has been closed for far too long, without a plan to restore the services that students are paying for the University to offer. We're proud of the grassroots efforts of our community, highlighted by <u>this petition</u>. We have uplifted these concerns and directly urged administration at the University to be transparent with its timelines for reopening, and prioritize restoring this service that is so essential to students. These conversations have occurred both directly with administration, and in our <u>public call for the University to</u> <u>do better</u>.

#### **Campus Food Bank Board Retreat**

This past weekend, I attended the Campus Food Bank Board of Directors retreat. This was a strategic planning session where board members discussed how we want the board and the centre to function to best serve the demands that the Campus Food Bank faces. We focused on capacity building, funding and fundraising opportunities, and structural refinements that can be made to run the centre and the board as effectively as possible during these unprecedented times.



#### **Golden Bears and Pandas Legacy Fund**

Last week, Levi and I attended the GBPLF committee, where we worked with the other committee members to allocate these student funds to projects that would benefit our athletics teams and broader university community. Code of Conduct Appeal January 2024



#### Overview

The Student Governance Code of Conduct is a regulatory document for all actions and proceedings related to student representatives of the University of Alberta Students' Union. The Code of Conduct exists to create, enforce and protect equitable practices and spaces in UASU governance.

Recently, a complaint was submitted to the Speaker of Students' Council for review, citing that a member of Council breached the Code of Conduct. Upon receiving the complaint, the Speaker ruled that the complaint required no further action. The complainant has since appealed the Speaker's decision to Students' Council for review.

Students' Council's role in this process is to listen to relevant testimony and examine the Speaker's decision for the purpose of either upholding the Speaker's ruling that the complaint requires no further action or overruling the Speaker's ruling and requiring further action be taken on the complaint. Council shall evaluate if the Speaker correctly identified the needs, substantiveness and purpose of the complaint and whether further process needs to be taken, despite any barriers or misgivings that the Speaker has identified. When considering an appeal, Students' Council must also uphold the values and principles of the Governance Code of Conduct.

Specific information in regards to the complaint cannot be conveyed at this time to uphold the safety, security and privacy of all those involved. Further details about the complaint will be provided confidentially to Students' Council during the meeting that the complaint appeal is heard.
